IT IS WITH GREAT PLEASURE THAT WE CAN REPORT TO YOU THAT THE SELISHER CITY COUNCIL PASSED A RESOLUTION TO PROCLAIM THE BETH ALMIN " AN HISTORIC MONUMENT ", CONDITIONED THAT WE JEWISH EMIGRANTS FROM THAT AREA WILL ASSUME THE RESPONSIBILITY FOR THE ENTIRE BUDGET OF RESTORING AND MAINTAINING IT IN A CLEAN AND ORDERLY FASHION BEFITTING AN "HISTORIC LANDMARK". IN ORDER TO PROVIDE BETTER SECURITY AND TO SAFEGUARD IT FROM FURTHER VANDALISM, THE CITY COUNCIL REQUIRED US TO CONSTRUCT ABOUT A THREE METER HIGH CONCRETE STONE FENCE ENCLOSING IT FROM ALL AROUND ( CIRCA HALF A KILOMETER ) AND TO ENGAGE A STEADY ATTENDANT.

DAN OUR RECENT TRIP WE OBSERVED THE ACTUAL CONSTRUCTION IN PROGRESS AND WERE ABLE TO TAKE SOME VIDEOS OF SAME. WE ARE PLEASED TO ATTACH SOME COPIES OF PHOTOGRAPHS OF THE UPCOMING NEW FENCE.

HOWEVER, THE SELISHER BETH ALMIN IS NOT A SYMBOLIC ONE, IT IS THE GENUINE ETERNAL MEMORIAL SITE OF OUR SELISHER ORIGINAL ROOTS AND ANCESTORS. CAN WE EVEN IMAGINE A THOUGHT OF ABANDONING IT (AS SOME SUGGESTED) AND LET THE RUSSIAN AUTHORITIES DESTROY IT AS THEY, ALAS, ALREADY DID SO IN MANY OTHER AREAS? CHAS V!CHOLILE.
